



MDRT welcomes Ontario financial advisor to leadership team

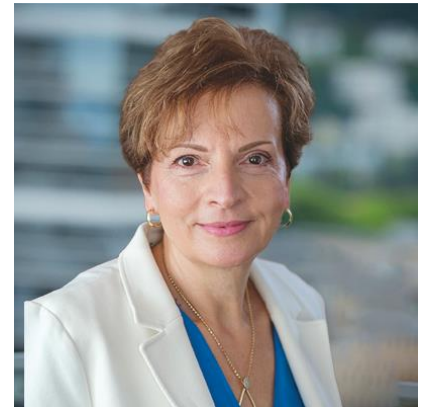
